Limited Warranty - DOCKS & STAIRS

MC Docks, LLC warrants its **Metal Craft® DOCKS** boat dock/pier and stair products to be free of defects in materials or workmanship under normal and proper usage from date of purchase for:

- **15 years** - All aluminum parts.
- **15 years** - Ace Rotomold Floats (first ten years 100% non-prorated, additional 5 years pro-rated).
- **5 years** - Relating to poly-acrylic paint adhesion defects only. This warranty does not cover paint wear due to normal use or damage to the paint surface.

The 15 year Warranty on aluminum parts applies to products purchased after January 1, 1997.

MC Docks, LLC is not responsible for removal or installation charges incurred to facilitate repairs or replacement.

Should a breach of this warranty occur, **Metal Craft Docks, LLC** will either, in its sole discretion, provide a replacement part or will repair or replace the entire dock section upon return of the product to the place of purchase by customer.

This warranty does not cover any damage resulting from the mishandling or misuse of the products or for any damages resulting from acts of nature including but not limited to storms, high winds or ice.

IN NO EVENT SHALL **MC Docks, LLC** BE RESPONSIBLE FOR CONSEQUENTIAL DAMAGES.

Limited Warranty - LIFTS

Metal Craft Docks, LLC warrants its **Metal Craft®** boat lift and PWC lift products to be free of defects in materials or workmanship under normal and proper usage from date of purchase for:

- **15 years** - All aluminum parts and aluminum welds
- **2 years** - All other components (e.g., cables, pulleys, bunks, fasteners, etc.)

Winches, canopies, electric motors, etc. under Warranty provisions from the original manufacturer.

MC Docks, LLC is not responsible for removal or installation charges incurred to facilitate repairs or replacement.

The customer must maintain a current and accurate warranty card with Metal Craft Docks.

Annual lift maintenance procedures must be completed per Metal Craft Lift recommendations and records provided with any and all warranty claims.*

Should a breach of this warranty occur, **MC Docks, LLC** will either, in its sole discretion, provide a replacement part or will repair or replace the entire lift upon return of the product to the place of purchase by customer.

This warranty does not cover any damage resulting from the mishandling or misuse of the products or for any damages resulting from lift over-loading, or acts of nature including but not limited to storms, high winds, or ice.
